From 1 August, I will have a vacancy as a healthcare and nursing assistant in Tyrol. I completed the 3-year training programme as a healthcare and nursing assistant and graduated in 2020 and have been working until now.



Example A - Return third country binational couple

Return United Kingdom, pension, work

I am German, have lived and worked in the UK for 18 years, where I also met my partner, and am just starting to prepare my return and his immigration to Kiel.

One of the biggest questions is the status of my partner, as the UK is no longer an EU country 'thanks' to Brexit and we are not (yet) married (but are considering it). He is 71 and a pensioner, and I am wondering what this means for his enrolment in a statutory health insurance scheme, for example. Furthermore, through friends and family I have I have always maintained close contact with Germany, but I am not up to date with regard to entitlement to social benefits, reintegration into the German social security system, pension, etc.

Returning USA, Single

I do not know the language anymore unfortunately, but since it is my first language, I believe I can re-learn it very quickly. My questions:

- I would like to move to Berlin are there any affordable 1 bedroom or studio flats available? My budget is around \$1,000 / € 850 a month
- How can I qualify for government assistance while I am looking for work?
- Are there any free, in person, German language courses I can take when I arrive?
- Are there any places I can work that won't require German while I still learning the language?
- how can I set up my healthcare?

Example C - Return due to financial problems


Already returned

Hello, hello, we are a family and emigrated to Panama last year. We were given the wrong advice regarding work visas and residency, so we cancelled our plans because we were facing horrendous costs (€15,000 for visas and residency visas).

We left Panama in February because the time for the tourist visa had expired and made a stopover in Mexico. Once we arrived there in April, our current account was almost completely emptied by a fraud, so we ended up stranded in Germany with our last resources and a "sponsored" Lufthansa flight ticket.

We are currently staying with a small family in an even smaller flat for a few days. Now we need bridging money for a period of 5-6 weeks until I get the money back. The employment agency/job centre are not helping, as neither financial support nor accommodation can be organised promptly. At the moment I don't see and have no solution as to what or who can help us. With financial support it is clear that it will be paid back in the short term.


